Road Traffic Regulation Act 1984

Notice is hereby given that KENT COUNTY COUNCIL intends to make the above Order under sections 1(1), 2 (1) to (3), 3 (2), 4 (1) and (2), 32 (1), 35 (1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby proposes to make the following order:-

The effect of the proposed named Order will introduce or amend existing waiting restrictions on the following lengths of road (in this part of the notice DYL's means double yellow lines) waiting to be prohibited at any time

Roads in Maidstone in the Borough of Maidstone

BUFFKYN WAY – DYL – (1) On the north east side from its junction with Gore Court Road for a distance of 40 metres in a south easterly direction. (2) On the south west side from its junction with Gore Court Road for a distance of 31 metres in a south easterly direction. **ELLIS FIELD – DYL –** On both sides from its junction with Pentecost Lane for a distance of 5 metres in an easterly direction. **GORE COURT ROAD - DYL –** On both sides from a point 36 metres south west of its junction with Buffkyn Way to a point 11 metres north of its junction with Pentecost Lane. **PENTECOST LANE – DYL –** Both sides for its entire length. **SENDLES FIELD – DYL –** On both sides from its junction with Pentecost Lane for a distance of 5 metres in a southerly direction. **SUTTON ROAD – DYL –** Around the entire circumference of the traffic layby island opposite the junction with Buffkyn Way. **SUTTON ROAD LAYBY OPPOSITE BUFFKYN WAY – DYL -** (1) On the south western side of the eastern end of the layby for a distance of 14.5 metres in a westerly direction. (2) Between points 35.5 metres and 45.5 metres. (3) Between 52.5 metres and 59 metres. (4) Between 90.5 metres and to its junction with the west end of the layby. **To install a 24 hour loading bay –** (1) On the southern side at the eastern end of the layby from a point 14.5 metres for a distance of 20 metres in a westerly direction. **WHITE HORSE LANE – DYL –** On both sides from the junction with Pentecost Lane for a distance of 164 metres in an easterly direction.

The KENT COUNTY COUNCIL, acting as the Local Traffic Authority and in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49, 53, 122 and 124 of the Road Traffic Regulations Act 1984 (hereinafter called “the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Schedule 9 to the Act, hereby propose to make the following Order:-

Revocations, Modifications and Amendments

In this Order the expression “Order of 2017” means "The Kent County Council (Various Roads, Borough of Maidstone) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2017” (“the Order of 2017”) shall have effect as though:

In the Schedules to the Order

FIRST SCHEDULE
STREET OR LENGTH OF STREET
WHERE WAITING IS PROHIBITED AT ANY TIME

Roads in Maidstone in the Borough of Maidstone

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

BUFFKYN WAY (1) On the north east side from its junction with Gore Court Road for a distance of 40 meters in a south easterly direction.

(2) On the south west side from its junction with Gore Court Road for a distance of 31 metres in a south easterly direction.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

ELLIS FIELD On both sides from its junction with Pentecost Lane for a distance of 5 metres in an easterly direction.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

GORE COURT ROAD On both sides from a point 36 metres south west of its junction with Buffkyn Way to a point 11 metres north of its junction with Pentecost Lane.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

PENTECOST LANE On both sides for its entire length.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

SENDLES FIELD On both sides from its junction with Pentecost Lane for a distance of 5 metres in an easterly direction

The following to be inserted in the First Schedule of the Order of 2017 in place of the existing entry:-

SUTTON ROAD

- (1) On the north-eastern side from its junction with Cranbourne Avenue in a southerly direction for a distance of 14 metres.
- (2) On the south-western side
 - (a) between points 10 metres westerly and 10 metres easterly of its junction with Mangravet Avenue;
 - (b) between points 25 metres north-west and 5 metres south-east of its junction with Grove Road;
 - (c) around the entire circumference of the traffic layby island opposite the junction with Buffkyn Way.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

SUTTON ROAD LAYBY OPPOSITE BUFFKYN WAY

On the south-western side of the eastern end of the Sutton Road Layby

- (a) for a distance of 14.5 metres in a westerly direction;
- (b) between points 35.5 metres and 45.5 metres west of its junction with the Sutton Road Layby;
- (c) between points 52.5 metres and 59 metres west of its junction with the Sutton Road Layby;
- (d) between points 90.5 metres and its junction with Sutton Road in an easterly direction.

The following to be added in to the First Schedule of the Order of 2017 in the correct sequence:-

WHITE HORSE LANE On both sides from the junction with Pentecost Lane for a distance of 164 metres in an easterly direction.
