7 COUNTY COUNCILLOR'S REPORT: (Submitted by email – see Appendix A) KCC has faced various issues trying to get to grips with Tier 4. An asymptomatic testing service is available in Detling, with another one opening soon at County Hall.

Over 300 meals were funded for residents in Maidstone SE over the Christmas period.

Whilst it is not clear in what format the elections will go ahead this year, Cllr Cooke confirmed that he will be standing as KCC's Conservative candidate.

KCC has provided new 'road closed' signs but these are the same as previously supplied (smaller versions are not available). Therefore Cllr Weeks will go ahead and purchase the previously agreed lightweight signs.
